Visas, ETAs and other Travel Documentation

This section covers the travel documentation and papers you will require when travelling to the United Kindom.

Passports and Identity Cards

This description is slightly simplified: for complete and accurate information please check the UK Border Control web site.

In general, in order to enter the UK, each person looking to enter must have a passport. There are limited exceptions to this: Irish Passport cards are acceptable. While National identity cards from EU countries, Ireland, Switzerland, Norway and Lichtenstein are also valid *if* you have applied for settled or pre-settled status *and* you have applied for a visa, we would expect this applies to very few convention attendees.

The passport must still be valid (that is, in-date, not expired) when you plan to leave the UK. While there is no other validity requirement apart from this, airlines have been known to misunderstand this and demand three or six months' validity beyond your date of leaving the UK. We'd recommend that you make sure you have plenty of validity left on your passport.

Passports can take a long time between application and receipt: if you think a new one is necessary or even useful, we also recommend applying as far in advance as possible.

Visas and ETAs

Visas

While visitors from many countries do not need a visa to enter the UK, there is a long list of countries for which a visitor needs a visa.

Whether or not you need a visa, you may be asked a number of questions regarding to prove that you are here for tourism, including what you will be visiting, how you are able to support yourself and your family during your trip, the accommodation arranged for your stay, how you will be able to pay for your return or onward journey (or have funding from someone else) and how you'll leave the UK at the end of your visit. Make sure you have evidence of this.

Registration at Glasgow 2024 can help with an invite letter, to show why you are visiting.

Electronic Travel Authorisations

The UK is rolling out Electronic Travel Authorisations over the course of 2024. These operate in a similar manner to The US's ESTA and Canada's eTA. Once fully rolled out, anyone who does not need a Visa to enter the UK will need an Electronic Travel Authorisation. These will cost £10 and last for two years, or until the expiry of your passport if that is sooner.

These are being rolled out in stages.

If you are from Qatar, Bahrain, Jordan, Kuwait, Oman, Saudi Arabia or the United Arab Emirates, you will need one. You can apply for one on the UK ETA app, which is linked on the UK ETA application page.

Other countries will be regularly added to this list: it is likely that by the time of the convention, many other countries will be added. We recommend checking the UK electronic Travel Authorisation website. often, and well before you travel.
